2. The relationship of the Paraclete to the world. The world
 - a. Cannot accept the Paraclete (14:17).
 - b. Cannot see or recognize the Paraclete (14:17).
 - c. Rejects the Paraclete (15:26).
 - d. But its rejection does not prevent the Paraclete's witness to Christ (15:26).
 - e. Is condemned, proven wrong, and pronounced guilty of sin by the Paraclete (16:8-11). (John 16:8-11 is a very difficult passage both to translate and to understand. But the summary catches at least some of its basic meaning.) [emphasis ours 2021-05-08]

[I thought I better start from the beginning of the chapter on "The Hijack of the Message of Jesus" since we have some time until 2050 to finish this message, complements of Jagbir. The Hijack of the Message of Jesus – Part 1

"It is certainly not very original to point out that Jesus of Nazareth is the most influential person who has ever lived in the course of recorded human history. More blood has been shed in his name and more good done, than in connection with any other person; more movements have claimed him as patron, and more books have been written about him, than about any other person who has ever lived.

Tragically, however glorious his message undoubtedly was, it suffered the fate of many another glorious message in the ways in which it was warped and damaged almost beyond recognition down the centuries. But in the case of Jesus this seems to have happened almost from the very beginning.

Given that the arrest and torture of Jesus took place a day and a night before Passover, and that his early followers were Jewish, it was almost inevitable that his message would have become interpreted through the major themes of Passover, and later of Yom Kippur, the pre-eminent Jewish Day of Atonement to God for our sins. Thus, even very early on, the main elements of his teachings were already side-tracked.

Before the destruction of the Jerusalem Temple in 70 AD, the ceremonies of Passover culminated with the sacrifice of a spotless lamb on the altar of the Temple. The flowing of the lamb's blood down the stone of the altar was seen as a symbol of our sins being washed away in the sight of God. (p.62) In the traditional accounts of the Passion of Jesus there was no shortage of the flowing of blood. After the crown of thorns was pressed into the head, Pilate ordered a scourging way beyond the legal limit, in the hope the Priests and mob before him would be appeased by the sight of so much blood and suffering. The first Epistle of Peter testifies that that scourging was particularly savage. Against this powerful and dramatic background, the role and message of Jesus almost immediately came to be understood as intimately related to blood sacrifice for the atonement of sin, about which he had not said a word during his public ministry, even though blood sacrifice was prominent in Jewish tradition. The authenticity of the so-called ransom statement of Mark 10:45 **[19]** is much disputed, and it is apparent that in the context of the narration of the Last Supper in Matthew, Mark and Luke, the only blood Jesus has in mind is the red wine of the Eucharistic meal.

As will be explained in more detail later, in the ancient mystical traditions the symbolic meal of a great spiritual Master with his disciples, was designed to celebrate their incarnation and evolution through life's journey. This mystical meal was focused on bread, wine and water, symbolizing the three elements that constitute the human being: the spirit, symbolized by the wine, the physical body, symbolized by the bread, and the water, symbolizing the soul that keeps the memory of the spirit's journey. It was believed that in such a ritual meal the Master could transmit his DNA into the bread and wine the disciples consumed. Any suggestion of even implying a literal blood sacrifice is light years away from any of these historic sacred enactments, and most especially from the one that was enacted with Jesus and his disciples.
